

WHAT IS THE LOGGER OF EXCELLENCE PROGRAM?

The Logger of Excellence program is a recognition initiative that was designed and implemented by the West Virginia Division of Forestry to place positive emphasis on those professional loggers in the State of West Virginia who go above and beyond the requirements of the law during a given calendar year.

HOW DOES A LOGGER QUALIFY?

To qualify as a Logger of Excellence for a given calendar year, a licensed timber operator must meet the following requirements:

- The operator must have had a valid Timber Operator's license for the entire year.
- The operator must be and have been in compliance for the entire year with regard to the WV Business License, Worker's Compensation, and Unemployment Compensation.
- No compliance or suspension orders issued to the operator by the WVDOF during the calendar year.
- Operated during the full calendar year and harvested at least 100 acres during the year.
- The operator's jobs must have been inspected at least twice for compliance by the WVDOF.
